And so the terribly long wait is finally over – St Stephen's has a new Vicar. Even though I have been here since August last year, we took the decision to delay my Induction and Installation until my family could all be here, which meant having to wait until after Christmas. And what a special evening it was!



Thank you so much to all who were involved in making the service of Induction and Installation such a memorable and enjoyable evening. Even though the weather was atrocious, there were over one hundred people who attended the evening. It is hard to imagine that it would take so long from January 2022, when Dean Tim and I first spoke with each other. I must say that the Dean has been hugely supportive of this process throughout (thank you Dean Tim). Thank you also to Tony and Marg and Elis for their encouragement and having the faith to keep going – we hope it has been worth the wait!

Ministers of the devil

"All the Guernsey people are rascals and the clergymen ministers of the devil.' This was the opinion publicly expressed by the Revd. Basil Blogg Babington, when he was resident in this island. A little background may be necessary to explain this rather frank statement.

Basil Blogg Babington was born 28th March, 1846 at Madras, India. He was the son of Lt. Gen. David Staig Babington and Maria Anne Sutherland, daughter of Maj. Gen. Sir James Sutherland, KBE. He had five brothers and three sisters. Two of his brothers were clergymen, the other died at the age of 24. He was educated at Wellington College and was admitted to Lincoln College, Oxford matriculating in October 1864. He then migrated to Charsley's Hall. The Oxford Magazine, 1889, states that: ... and yet if they, through lack of natural ability, fail to pass Mods, by a certain time, down they go and nothing is left them but to migrate to Charsley's Hall, itself perhaps to be abolished ere long. The life of a man at a private hall now-a-days is utterly different from that of a man at New Inn Hall as it used to be. Some of the restrictions (we hope Mr. Charsley will pardon us) are vexatious in the case of men residing at the Hall.. Charsley's Hall features in the *Lay of the first minstrel,* A parody of Sir Walter Scott:

It was an Oxford Scholar bright, (The sun shone fair on Charsley's Hall,) And he would get him thoroughly tight, For <u>Gilbey'</u>II still be lord of all...

He gained his BA in 1868 and MA in 1871. He was ordained deacon by the Bishop of Gloucester and Bristol in 1869 to a title at St Mary Redcliff, Bristol and priested by the Bishop of Barbados in 1870. He was a Minor Canon of Bristol Cathedral from 1870-77.

He as appointed to the Rectory of the new parish of Westwood, Wiltshire in 1977 and remained until 1884.

It seems, according to family tradition, that he was indirectly involved in a scandal concerning a servant-girl at Westwood, which may have resulted in him resigning the living and coming to Guernsey, where he resided at Les Bourgs, St Andrew's, now the hospice. However, four young children died at the Rectory in Westwood between 1878 and 1882, so it is perhaps understandable why he chose to move.

In November 1883, Mr. and Mrs. Babington were charged by Mr. De La Mare, constable of St. Andrew's with neglect and improper care of an adopted child, named Minnie Walters.Dr. E. K. Corbin having stated that he had that morning seen Mrs. Babington, who was in such a state that the excitement of being brought up at Court, might be followed by serious consequences, the Court dispensed with her presence on Mr. Babington saying that he had no objection to that course. Mrs Babington was heavily pregnant at the time.

The Queen's Procureur said that before going into the case he wished to give a few facts which would assist the Court in understanding it. On Wednesday week the Constable came to him with a charge against Mr. Babington of having starved this child; she had run away from home, and had been found three days afterwards inadequately clothed, and refused to return.

On the following day Mr. Henry D. Mauger came to his office, in company with the Constable, to withdraw the case. The charge of starvation not being sustained, nor that of inadequate clothing, it being explained by Mr. Babington that the child was in the habit of tearing up her clothes. It was then decided to withdraw the case, on condition that the Constables have access to her once a month, to see that she is properly cared for. A point was then raised as to who should pay the expenses, these were eventually defrayed by Mr. Babington. On Monday last two gentlemen, Messrs. Frank Carey, of The Cottage (La Chaumière) and W. Turnbull, of Kilburn, Rohais de Haut, came to his office, and laid a charge against the Constable for having withdrawn the case, stating that undue influence had been brought to bear on him (the Constable). He (the Procureur) then wrote to the Constable, and ordered him, if he was of opinion that there had been cruelty, to bring the case before the Court today.

Advocate W. Carey, who defended prisoner, asked that his client be allowed to sit down, as he was suffering from a bad foot; this was consented to by the Court.

Constable De La Mare deposed that on Tuesday week, William Robert, a workman of Rev. J. U. Pilbeam's came to him, and said that the Rev. Mann, had been to prisoner's residence to enquire about the lost child and found all the gates locked, this coupled with the fact of the girl's disappearance looked mysterious. He and Mr. Carré (his colleague) went there the same afternoon. and found the gates locked, but seeing smoke coming out of the chimney, they concluded that someone must be in. Mr. Babington at last came out and spoke to them, remaining on his own property, and the Constables in the road. Mr. Carré asked him if he had advertised the girl that had been lost, he replied that he had not but intended to do so. Mr. Carré told him that a newspaper came out that evening and he had better advertise in it. At 5 o'clock on the same day, witness heard that the girl had been found at Mr. Thomas Mauger's, at the Tertre, he went there and found the child without shoes or stockings, and only covered with a light garment in rags. She stated to witness that she would not go back home as she was ill-treated, and requested to be taken to the Hospital. The witness took her in a cart to the Hospital, she stated that she had worn shoes only twice since they had come to Guernsey.

Constable Carré deposed that on Sunday week last at about II o'clock, Mrs. Babington, came to ask him to go to the Bourgs, to seek in a hay loft for the missing child, he went there and searched in the hay loft and about the premises including the well, but found no traces of her. He asked them if the child was theirs, when they said it was not, but she had lived with them for nine years, and was an idiot. She had disappeared on the previous day about noon and added that she was afraid of thunder and witness remembered that a thunderstorm took place on the morning of that day.

Dr. E. K. Corbin, deposed that on Wednesday week Constable De La Mare, called him to see a child at the Castel Hospital who it was alleged had been ill-treated, and beaten; he went there and examined the child but found no bruise or mark of any kind with the exception of a scar on the right foot, which he had no doubt been caused through going about bare footed, she was well nourished, he had heard the history of the alleged ill treatment, and questioned the child; he found her uncommonly intelligent, and she stated to him that she slept on the floor at home, as she had no bed. Mrs. Thomas Mauger residing at the Tertre, stated that the girl came and knocked at her door on Tuesday week last at about 4.30 p.m. She was in rags and asked to be taken in for the night, and then to the Hospital the next day. Her arms were bare and one of them was numbed with the cold, she said she would not return to her home, as she was ill-treated.

Several witnesses deposed as to having seen the child about the garden on several occasions in a state of semi-nudity.

Frederick Bichard, master of the Castel Hospital deposed that the child was brought to that Institution very inadequately clothed, some clothes were sent there for her by Mrs. Babington the next day, which were in a very dirty state. Mr. Thomas Lenfestey deposed that Mr. Babington had called on him since the alleged ill-treatment became known, witness spoke to him about it, and Mr. Babington thereupon became furious, and said that there were reasons for the child lying on the floor, adding that all the Guernsey people were rascals, and the clergymen ministers of the devil. He had previously offered to undertake the duties of the Rev. Mr. Mann, in case the latter were unable to attend to them.

Annie Johnson, deposed that she was servant at the Rev. Babington's and had been two years in his service. He had three children, the little girl in question was not his, but an adopted child; this child slept with her, and the youngest boy, who was three years old, in a room called the nursery. She was untruthful, dishonest, and walked in her sleep, she was also affected by thunder. Witness had the care of the children, besides cleaning the house, washing, cooking and waiting. This child had a bath daily, and would often take off her boots and stockings, preferring to run about without them.

The little girl was now questioned, she said that she was 10 years of age, she could not remember where she had been during the three days she was away from home; all she remembered was that she crossed some fields. She did not go to school. She was asked whether what she had said to Mrs. Mauger and the Constable as regards ill-treatment were true. She could give no satisfactory answer to this, appearing to have forgotten everything.

Mr. Henry D. Mauger, Her Majesty's Sheriff, called by the defence stated that on Wednesday week last, Mrs. Babington called at his Office; she was in a very distressed state about the charge, and seeing her condition, he took it upon himself to go to the Constable to see if the matter could not be arranged without bringing the case before the Court. The Constable having told him that the Procureur had been seen about the case, they proceeded to Mr. Carey's Office together, and the matter was arranged as that gentleman had stated. Questioned by Advocate W. Carey, Mr. Mauger added that he paid the expenses himself without consulting Mr. or Mrs. Babington in any way or having been requested to do so by them beforehand, he did not do it professionally and would not be remunerated; he took it all upon himself seeing the distressed state of the lady.

Advocate W. Carey for the defence said that the first charge, that of illtreatment, was not made out. The constable had withdrawn the case on being promised payment for expenses incurred, several days afterwards, knowing and taking advantage of the fact that Mrs. Babington was in a very advanced state of pregnancy, he asked for more money as some of the witnesses wished to be paid for their time; and threatened that if the extra money were not forthcoming he would bring the case before the court . It was infamous that a public official should be guilty of such conduct, he was ashamed of it as a Guernseyman, he hoped that the court would dismiss the case and severely reprimand the constable for his conduct, in bringing up the defendants to court on such a frivolous charge. There was no evidence of neglect, the servant had plainly stated that the child tore her clothes, and would always go about without boots or stockings; the child, affected by thunder, had gone away from home, and did not remember where she had been. There was no evidence of neglect in all this, and the Doctor had plainly stated that she was well nourished and in good condition, and bearing no marks of ill-treatment. Mrs . Babington, moreover though in a bad state of health had instigated a search for the child as was proved by Constable Carré.

Her Majesty's Comptroller said that the charge of cruelty and starvation fell to the ground, there being no evidence to prove these, on the contrary, the evidence of Dr. Corbin went to show that the child was in good condition. Next came the charge of neglect. Mr. Babington having adopted the child was bound legally and morally to exert the same care over her as he would over his own. She had been seen on several occasions inadequately clothed. One point the Comptroller thought showed want of interest in the child, that was, that the child was missed from home on Saturday about noon, and it was not until Sunday at 11 o'clock that Mrs. Babington went to the Constable. If the Court thought the charge of neglect sustained, he considered that bail should be required that the child be well cared for, for the space of twelve months, and moreover that the Constables have access to the child at any time to satisfy themselves as to her proper state.

The two Jurats present adopted the conclusions of Her Majesty's Comptroller, the amount of bail being fixed at £30.The bail was given.Mr. Babington did not return to England, but was chaplain at Caen 1884-85, Assistant Chaplain at Rouen, 1888-90, and at Gotha 1890-91. He then returned to his homeland, being a Licensed Preacher in the Diocese of Exeter 1895-1901. He then retired and died 11th November 1928 at Paignton, Devon.

Also don't forget those used printer cartridges, unused mobile phones, newer versions please.


CD's, DVD's computer games, unused Kindles, or Games Consoles, give them all to Steph.




